This is an issue for several reasons:

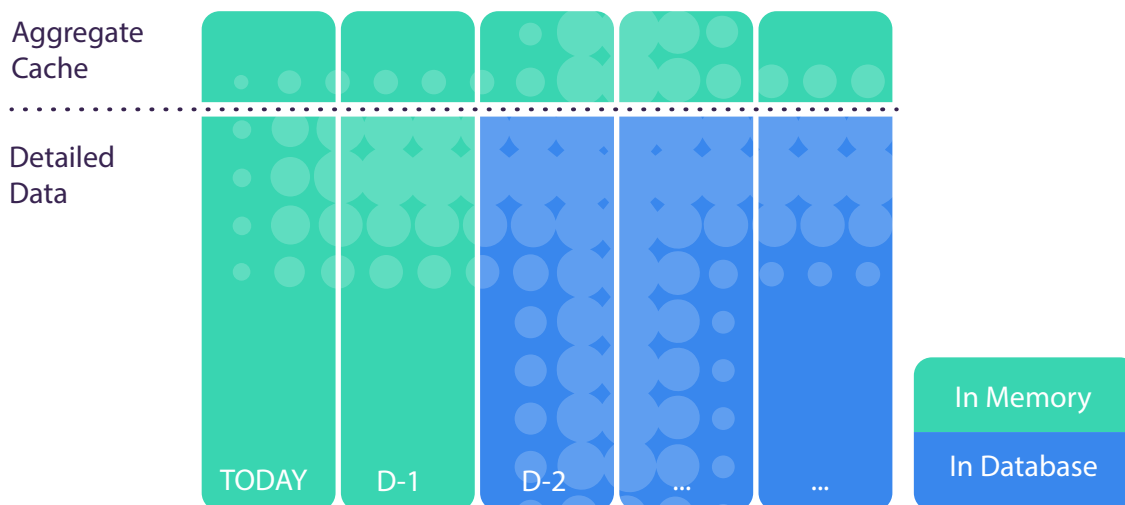

It works with every public and private cloud provider, with on-premise deployments, and even across multiple clouds and databases. The experience is completely seamless.



An optimized deployment of Atoti+ with DirectQuery will load in-memory the most commonly accessed data as a fully-fledged analytics cube and leave trade-level historical data on a slightly slower but less expensive database, since it is less frequently used. For the end-users, the process is completely transparent.

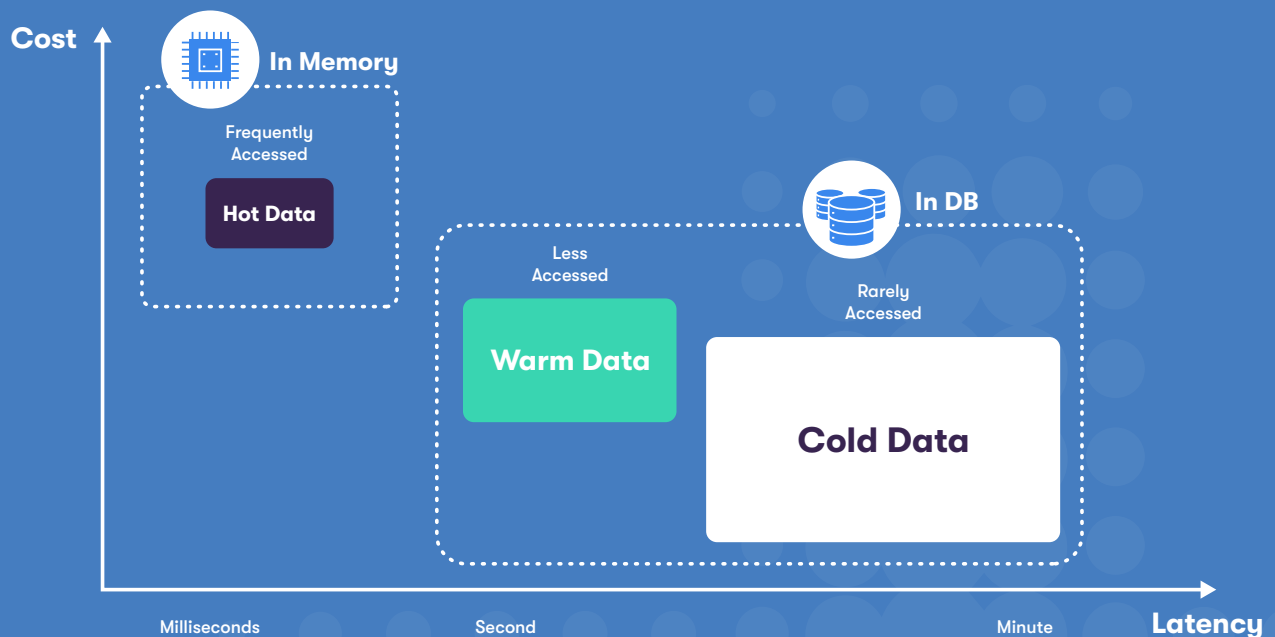
Deploying Atoti+ with DirectQuery for almost every risk analytics use case brings several major, unique benefits that no other solution on the market can offer.

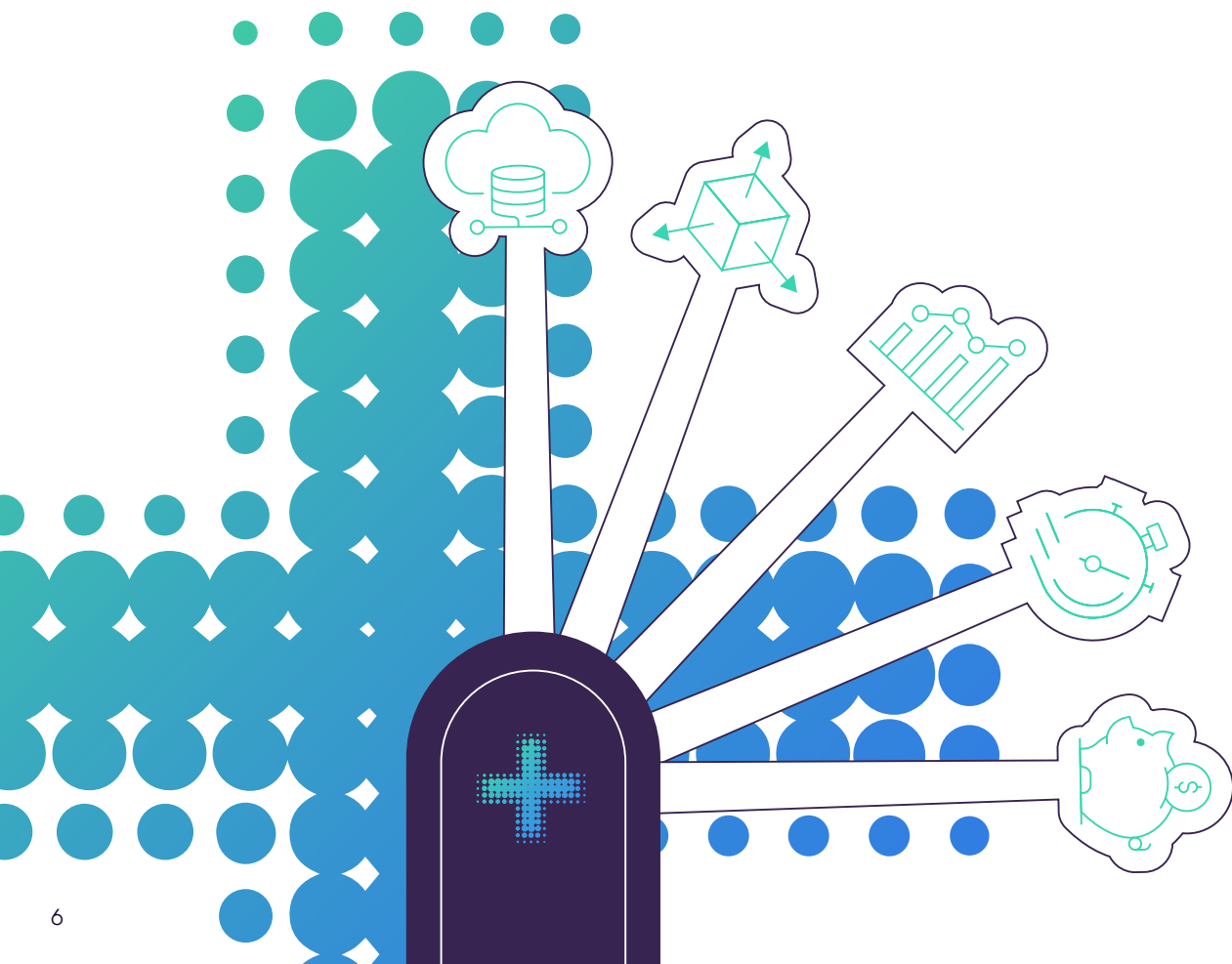
- + By bringing several tasks onto a single platform, companies save on licensing, support and maintenance
